

As the parent or legal guardian of _____,

- I affirm that my child does not have any symptoms of Novel Coronavirus COVID-19 currently, or within 14 days of the start of AWANA at Brimfield Evangelical Free Church beginning on 09/16/2020. My child also does not currently have or has had within the last 14 days any other respiratory illness or flu-like symptoms including but are not limited to:

- Coughing
- Fatigue
- Fevers/chills
- Loss of smell
- Sore throat
- Unexplained rashes
- Muscle or body aches
- Nausea or vomiting
- Diarrhea
- Runny nose/congestion
- Strawberry tongue

1. In the last 14 days my child has not come in contact with anyone who has to my knowledge tested positive or displayed the symptoms above or any other respiratory of flu like illness. If they do become exposed, I will keep them from participating for 14 days to prevent exposure to others.
2. I understand that before my child can participate, they will have their temperature checked at the start of every evening's events, and I will need to fill out the forms required completely and accurately at registration. Any child with a fever will be sent home.
3. If I find that my child displays any of the symptoms above, tests positive for COVID-19, or develops any respiratory or flu like symptoms I will keep them out of AWANA for 14 days from the time of initial symptoms or exposure. I understand that if the church must report exposure to parents and volunteers for their safety, no child's name will be released and the church will do all it can to protect the anonymity of my child if I need to report that my child has developed the symptoms above or tested positive for COVID-19.
5. I have instructed my child to follow the local mask guidelines and adult leaders and volunteers' instructions regarding masks and social distancing while inside the building or in proximity of other people.
6. I acknowledge the risks of gathering and participating in group activities during this time and I accept these risks for myself and my family. I release AWANA, Brimfield Evangelical Free Church, all employees, volunteers, leaders, agents, officers, representatives, and all other associated parties as well as ministries of the AWANA organization and the Brimfield Evangelical Free Church from any and all claims of injury, illness, or death as a result of COVID-19 infection obtained or possibly obtained while participating in AWANA or while on Brimfield Evangelical Free Churches property.

I have fully read this agreement and agree to follow the guidelines set forth by this document as well as advised my child to listen to the instructions of adults and comply with all guidelines related to reducing the spread of COVID-19. I acknowledge that these guidelines may not completely stop the spread of COVID-19 and I accept all risks and financial consequences of allowing my child to participate in activities at Brimfield Evangelical Free church as stated above in section 6.
